AN ORDINANCE FOR THE LEVY ASSESSMENT OF TAXES FOR THE GLENBARD FIRE PROTECTION DISTRICT DUPAGE COUNTY, STATE OF ILLINOIS

WHEREAS, the Board of Trustees of the GLENBARD FIRE PROTECTION DISTRICT of DuPage County, Illinois, did on the 26th day of October, 2021, adopt the Budget and Appropriation Ordinance of the District for the fiscal year ending on the 30th day June, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE GLENBARD FIRE PROTECTION DISTRICT:

Section I: LEVY - That there be and there is hereby levied upon all taxable property in the corporate limits of the GLENBARD FIRE PROTECTION DISTRICT subject to taxation for the year 2021, the sum of \$433,661.41 for the following specific purposes mentioned in the Appropriation Ordinance, in the respective sums as follows:

Section V: That the unexpended balance of any item or items of any appropriation made by this Ordinance may be expended in making up any deficiency in any item or items in the same general appropriation made by this Ordinance.

Section VI: That should any clause, sentence, paragraph or part of this Ordinance be declared by a Court of competent jurisdiction to be invalid, such declaration shall not affect the validity of this Ordinance as a whole, or any part so declared invalid.

Section VII: This Ordinance shall be known as Ordinance No. 107.

Section VIII: This Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with the law.
