

**ORDINANCE NO. 105**  
**2020 LEVY ORDINANCE**

AN ORDINANCE FOR THE LEVY  
ASSESSMENT OF TAXES FOR THE  
GLENBARD FIRE PROTECTION DISTRICT  
DUPAGE COUNTY, STATE OF ILLINOIS

WHEREAS, the Board of Trustees of the GLENBARD FIRE PROTECTION DISTRICT of DuPage County, Illinois, did on the 22nd day of September, 2020, adopt the Budget and Appropriation Ordinance of the District for the fiscal year ending on the 30<sup>th</sup> day June, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE GLENBARD FIRE PROTECTION DISTRICT:

Section I: LEVY - That there be and there is hereby levied upon all taxable property in the corporate limits of the GLENBARD FIRE PROTECTION DISTRICT subject to taxation for the year 2020, the sum of \$386,966.00.00 for the following specific purposes mentioned in the Appropriation Ordinance, in the respective sums as follows:

Section III: Each of the said sums appropriated and the aggregate thereof are deemed necessary by the Board of Trustees to defray the necessary expenses and liabilities of the District for general corporate purposes for the fiscal year ending June 30, 2021.

Section IV: That the funds derived from sources other than the 2020 levy may be allocated by the Board of Trustees to such appropriations and in such amounts, respectively, as the Board may determine, within the limits of said appropriation respectively.

Section V: That the unexpended balance of any item or items of any appropriation made by this Ordinance may be expended in making up any deficiency in any item or items in the same general appropriation made by this Ordinance.

Section VI: That should any clause, sentence, paragraph or part of this Ordinance be declared by a Court of competent jurisdiction to be invalid, such declaration shall not affect the validity of this Ordinance as a whole, or any part so declared invalid.

Section VII: This Ordinance shall be known as Ordinance No. 105.

Section VIII: This Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with the law.
